### Government Order

The undersigned is directed to convey the sanction for study leave (Ex-Bangladesh and without pay) of Mr. Md. 2. **The terms and conditions of this order are as follows:**

- (h) He will have to serve DPDC for 03 (three) years after completion of the study leave.
