
Government Order

The undersigned is directed to convey the sanction for study leave (Ex-Bangladesh and without pay) of Ms. Humayra Kabir Priyanka, Assistant Engineer, Power Grid Company of Bangladesh (PGCB) Ltd. in the Auburn University, Auburn, Alabama (USA), the United States of America from 01/01/2021 to 31/12/2022 or 02 (two) years from the start of journey (including travel time) :

2. **The terms and conditions of this order are as follows:**

- (a) He will join his current post in PGCB after completion of the study leave;
- (b) He will not be allowed to avail any benefit from PGCB during study leave;
- (c) The company possesses the authority to cancel his appointment if he fails to join PGCB after completion of the study leave;
- (d) He will have to submit document related to the study from the University to GM (P&A), PGCB at the time of joining;
- (e) He will have to serve PGCB for at last 03(Three) years after completion of the study. Otherwise he will be terminated from the service and he will have to pay a fine of Taka 1,000,000 (one million).
- (f) He will have to submit an undertaking mentioning the conditions above in a non judicial stamp valuing taka 300 (Three Hundred Taka).

3. This order has been issued with the approval of the competent authority.


